  - German court says: "training is allowed, memorization is not", you cannot repeat a song's lyrics.
- [Niche Substack article about AI nightmare scenario impacts the market](#)
  - Context:
    - fictional "memo from June 2028", imagining how the current AI boom could trigger a systemic economic crisis
    - core thesis: AI doesn't need to fail to cause a crisis, it just needs to succeed fast enough
  - 1. AI agentic coding tools destroy SaaS (software as a service)
  - 2. AI agents displace human interaction (e.g. travel booking, insurance renewal, financial advice)
  - 3. Overall impact on many white-collar workers becoming redundant
  - **FT calls it out (and The Economist too), saying the economics of the article don't make sense**, but calls it 'interesting as a "thought-provoking example of scenario analysis"'
